Economic uncertainty, labor shortages and shifting regulations are making it more difficult than ever for contractors to stay competitive. We polled contractors about their biggest concerns for the coming year, and in addition to an aging workforce and a specialized skills shortage, they identified supply chain issues and weakened or sluggish demand as their top concerns.

## WILL THERE BE ENOUGH LABOR TO COVER UPCOMING PROJECTS?

70% of construction companies continue to struggle to find enough labor, but Wisconsin is beating the averages with construction job growth of 4.4% over five years due to the state's continued commitment to quality technical education.<sup>1</sup>

#### **CONSIDER THIS:**

- Aging Workforce: Over 20% of workers are hitting 55+. Many skilled tradespeople are retiring, with fewer young workers entering the industry.
- Declining Quality: Less experienced workers and fewer regulations lead to poor workmanship, project delays and increased costs. 56% of contractors report concern that workers don't have adequate skills,<sup>2</sup> but studies show union workers provide more reliable skilled labor.<sup>3</sup>

#### HOW TO PREPARE:

Work with a large network so you can fill roles quickly with reliable, well-qualified workers. Steamfitters Local 601 trains apprentices, including recent high school graduates, and its program is consistently filled with top-level recruits. Construction has one of the highest turnover rates of any industry at 54%,4 which disrupts projects and drives up costs.

- Projects that are short on labor are twice as likely to have at least a 10% cost overrun and schedule slip.5
- · Motivation & job security: Some workers are chasing better wages and benefits and can leave without warning creating instability.

Over the past few years, more than 80% of construction materials have gone up in price. While price jumps have begun to stabilize, some experts say these elevated costs are here to stay.6

- Higher fees on materials from Mexico, Canada or China will squeeze project budgets and could lead to delays.


